Regulations regarding private swimming pools and spas

Colac Otway Shire Council wishes to remind you of the strict rules which apply to private swimming pools and spas.

Building Regulations require **ALL** swimming pools, which are greater than 30cm (300mm or 1 foot) in depth, to have an inspected and approved pool safety barrier in place. These rules apply regardless of whether the swimming pool is permanent or temporary. It is the law to have an **inspected and approved** safety barrier around your pool or spa.
