Community Update

April 2018

The Governance of the Great Ocean Road Regional Issues Paper has been released to promote discussion and seek feedback on opportunities to improve the management of the Great Ocean Road Region. It identifies that the current planning and management arrangements for oversight of the Great Ocean Road are overly complex and fragmented with a multitude of responsible public entities and no overarching, coordinated planning and delivery, no community forum for people to voice their concerns between planning proposals, and too much duplication and inefficiency in the allocation of funding and resources. A new management model is proposed.

Did you know that more people visit the Great Ocean Road than the Great Barrier Reef and Uluru combined?

Tourism is very important for our local economy - in the year ending June 2017 visitor expenditure in the region was \$1.3 billion supporting 9,200 jobs. More work needs to be done, however, to address the impacts on local communities and increase the local benefits from tourists (such as increased visitor expenditure and job creation). A new management model will bring a coordinated approach and focus to this challenge.
