Important Information

Penalties apply for:

- · Failure to apply to register a dog or cat.
- Dog or cat found wandering at large during daytime/ night-time.
- Your dog and cat must wear the registration tag provided at all times, to ensure the ownership of the animal can be quickly traced.
- The owner of any dog which RUSHES AT, ATTACKS, CHASES ANY PERSON OR ATTACKS ANOTHER ANIMAL CAUSING AN INJURY.
- · Your dog or cat must not cause a nuisance.

All dogs and cats **at 3 months of age** must be registered. All new animal registrations must also be microchipped.

Once your registration fee is paid this notice will be deemed to be your certificate of registration. Your animal tag is not valid until payment is made.

Replacement Tags

Replacement registration tags are available from the Council Office. A fee of \$2.00 is payable.

As of 11 April 2013

*Under the *Domestic Animals Act 1994* an owner registering a dog or cat for the first time will not be entitled to the reduced fee for microchipping alone but there are other categories for reduced fees. See fee information below.

Privacy Statement

The personal information requested on this form is being collected by Council for the enforcement and administration of animal control in accordance with Sections 10 & 18 of the *Domestic Animals Act 1994*. State Government Levy
