Council meeting snapshot

Adoption of 2023-24 Budget and Fees and Charges

At the June Council meeting, the 2023-24 Budget (including Fees and Charges) was adopted by Council. The annual budget seeks to support Council's provision of important services and infrastructure that are affordable for the community.

The 2023-24 Budget includes:

- 3.5% average rate increase
- \$7.5 million Asset Renewal
- \$8.7 million for Capital Works
- 62 new projects
- \$58.4 million income

The 2023-24 Budget will be available to view on Council's website.

Colac Otway Shire Grants Program 2023-24 Allocation of Funds for Community Grants

72 community organisations, clubs, event organisers and businesses from across Colac Otway Shire were allocated a share of \$311,500 in Council grants. A diverse range of community projects and initiatives across the shire were funded by the grants program.

Subdivision of land into 54 lots - 36-52 Bruce Street, Colac

Council resolved to issue a notice of decision to grant a permit for the staged subdivision of land into 54 lots at Bruce Street, Colac (land formerly owned by Council). This project seeks to address the need for residential housing in the shire.

Bulla Development Plan at 91-149 Forest Street, Colac

Council approved the development plan submitted by Bulla Dairy Foods to facilitate two further stages of investment at its existing milk processing plant in Forest Street, Colac. Bulla is a major employer in Colac, contributing significantly to the local economy, and this investment will reinforce its future in Colac over the longer term. The plan covers a small part of the site and is proposed to be enacted in two stages.

Part Road Closure - Hall Street, Cressy

Council approved the discontinuation of part of the road known as Hall Street, Cressy. The physical road in Hall Street, Cressy runs across the front of freehold titled land. This physical road will be abandoned in that section. The adjacent road reserve will continue to exist and be available for future use if required.

Notice of an Application for an Amendment to a Planning Permit

The land affected by the application is located at: 175 Aerodrome Road, Cressy The application is to amend permit number: PP11/2021-3 by an alteration to allow for unrestricted landings and take-offs, and removal of permit conditions 4, 5 and 6

The applicant for the amendment to the permit is: CSS Investments (Aust) Pty Ltd The application reference number is: PP11/2021-4

The application is for a permit to: Use and Development of the Land for an Airfield, Construction of Ten Hangars and Use of Existing Building as a Hangar, Use of the Land as a Place of Assembly (History Museum) and Display of One Business Identification Sign

You may look at the application and any documents that support the application at the offices of the responsible authority during office hours at Colac Otway Shire Council's customer service centres at 2-6 Rae Street, Colac and 100 Great Ocean Road, Apollo Bay. This can be done during office hours and is free of charge.

The application can also be viewed online at http://www.colacotway.vic.gov.au for the duration of the public notice period until a decision is made by Council.

Any person who may be affected by the proposed amendment to the permit may object or make other submissions to the responsible authority. An objection must be made to the responsible authority in writing, include the reasons for the objection and state how the objector would be affected. The responsible authority must make a copy of every objection available at its office for any person to inspect during office hours free of charge until the end of the period during which an application may be made for review of a decision on the application.

The responsible authority will not decide on the application before **8 July 2023.** If you object the responsible authority will tell you its decision.
