Deans Creek Precinct Structure Plan (PSP) **Community Reference Group - Expression of Interest**

Council is planning for Colac's population growth over the next few decades and will develop a structure plan to guide future land use, development and infrastructure within the Deans Creek Precinct Structure Plan (PSP) area at the western edge of Colac/Elliminyt.

We have an exciting opportunity for Colac residents to be a part of a community reference group to help guide what future development for the Deans Creek Precinct will be. You'll be contributing to an important local project that will accommodate much of Colac's residential development for the next 30 years - we're particularly keen to hear from women and young people in our community who'd like to be involved.

The Community Reference Group (CRG) will meet every second month for around 12 to 18 months to help inform the preparation of the PSP.

Planning and Environment Act 1987 **COLAC OTWAY PLANNING SCHEME**

Notice of the preparation of an amendment

Amendment C125cola

Colac Otway Shire Council has prepared Amendment C125cola to the Colac Otway Planning Scheme.

The land affected by the amendment is:

- 1. Colac West Development Plan Area (land bounded by Murray Street to the south, Rifle Butts Road to the west, Lake Colac to the north, and existing residential development and the former Colac High School to the east),
- 2. J Barrys Road, Colac Industrial Area Development Plan Area (south east of the intersection of Forest Street, Hearn Street and J Barrys Road, Colac), and
- 3. Industrial Zones in Colac.

The amendment proposes to:

- 1. Strengthen the planning provisions for land covered by the existing
 Development Plan Overlay Schedule 2 Future Residential Areas. It introduces a new Development Plan Overlay Schedule 9 which contains additional design requirements for the preparation of a Development Plan for land in Colac West bounded by Murray Street to the south, Rifle Butts Road to the west, Lake Colac to the north, and existing residential development and the former Colac High School to the east. The amendment also includes a statutory provision to prepare a Shared Infrastructure Funding Plan in association with the Development Plan.
- 2. Promote a range of lot sizes, including large lot sizes on land covered by the existing Development Plan Overlay Schedule 7 J Barrys Road, Colac Industrial
- 3. Amend the wording of Clause 17.03-1L in the Planning Policy Framework to promote a range of industrial lots sizes, including large lot sizes more generally in Colac.

Any person who may be affected by the amendment may make a submission to the planning authority about the amendment. Submissions must be made in writing giving the submitter's name and contact address, clearly stating the grounds on which the amendment is supported or opposed and indicating what changes (if any) the submitter wishes to make.

Name and contact details of submitters are required for Council to consider submissions and to notify such persons of the opportunity to attend Council meetings and any public hearing held to consider submissions. The closing date for submissions is 16 November 2023. A submission must be sent to the Colac Otway Shire, PO Box 283, Colac VIC 3250 or inq@colacotway.vic.gov.au

The planning authority must make a copy of every submission available at its office and/or on its website for any person to inspect free of charge for two months after the amendment comes into operation or lapses.
