3. QUESTION TIME

Questions Received in Writing Prior to the Meeting

Rod Spence, CORRA

In 2004 Council sold approximately 11 acres of Council land in Bruce Street, Colac for \$1,030,000.00.

1. Why can't this money be used to reduce debt or fund part of the capital budget?

It is a matter for Council to decide upon. There are no legal or particular restrictions in place which prevent the funds from being used to retire debt, except that which forms part of the Council decision which sets up the reserve in which the funds were allocated.

However, there are other reasons that need to be considered prior to doing so. For instance, is it fiscally responsible to utilise these funds to retire debt? All of Council's debt utilises fixed rate loans which are at an average fixed rate of 6.47% which also attracts penalties for early payout. Council is currently able to obtain short term investment rates from banking institutions of 8.08% for the funds held in reserve. Council is in this case behaving in a far more financially responsible manner by retaining the funds in reserve, which in turn reduces the demands on rate income.

In addition to this, Council should make sure that in disposing of a community asset, Council ensures that these funds are then used to acquire another asset that gives a positive return to the community.

2. How much of these funds have been used already? How were they spent?

Of these funds approximately \$40,000 has been used for boundary realignment negotiations and associated legal fees.

3. How much of these funds are still held by Council?

The sale of lakeside resulted in a net result to Council of \$930,000, Council agreed to place the \$930,000 from the sale proceeds into reserves. In taking into account question two (2) above, Council currently holds approximately \$890,000 of the proceeds from the sale. The details about the initial recognition of the reserve are included on page 107 of the 2006/2007 Annual report, and any alterations to the reserve will be included in all subsequent Annual Reports and Annual Financial Statements.
