Geelong City Deal - Kennett River Tourism Infrastructure Improvements – Project Update

You are receiving this letter as a resident or ratepayer of land in Kennett River, to provide you with an update on the **City Deal Project - Kennett River Tourism Infrastructure Improvements** being delivered by the Colac Otway Shire over the next two years.

Colac Otway Shire Council (COS) will receive \$18.9 million in funding from the Australian Government for various improvements to coastal infrastructure as part of the Geelong and Great Ocean Road City Deal. \$1.9 million of this amount is specifically allocated to delivering tourism infrastructure improvements in the coastal hamlet of Kennett River on the Great Ocean Road.

The Kennett River tourism infrastructure improvements will deliver parts of the *Kennett River Tourism Parking and Traffic Strategy* which was adopted by Council in July 2019 following extensive community consultation. City Deal works include:

- Road and parking improvements to both the local road network and the Great Ocean Road
- A new permanent public toilet facility and associated onsite wastewater treatment plant.

Since July 2020, the City Deals Project Team has undertaken the following:

- Update of the carpark and road improvements concept plan for Kennett River (drawing on the original Design Option 2 from Council's Strategy), as well as public toilet location options. This will be available for community comment from January 15, 2021. This concept plan now complies with Australian road standards and guidelines, and this has impacted on parking capability. The project team and consultants are working closely with key community stakeholders in developing a revised concept plan (Revision 2) which has important updates for community consideration *in progress*.
- Land Capability Assessment to determine viable areas for toilet location options completed.
- Wastewater treatment plant (WWTP) design inclusive of Wisconsin (sand) mound in which to dissipate treated wastewater. This is almost finalised and indicates the area west of the wetlands as the most viable option. This land is managed by Colac Otway Shire 90% complete.
- Toilet facility interior design in terms of cubicle numbers and cubicle type. Criteria for design is being based on carpark capacity and estimated queuing times *in progress.*
- Toilet location and aesthetics there are 2 parts to this assessment. A community survey of the preferred location and aesthetics will occur in April 2021 *upcoming.*
- Survey works for title re-establishment, zoning and overlay boundary confirmations completed.

- Liaison with Authorities as works progress. This includes Eastern Maar Aboriginal Corporation, Aboriginal Victoria, Environment Protection Authority, Corangamite Catchment Management Authority, Southern Rural Water, Regional Roads Victoria/VicRoads, Department of Transport, Heritage Victoria, Department of Environment Land Water & Planning, Great Ocean Road Coast & Parks Authority, Otway Coast Committee (as a transitional body) – *in progress.*
- Kennett River materials palette for the township to inform current works including external aesthetics for the new public toilet facility *upcoming.*
- Kennett River Masterplan to illustrate community vision for the township beyond the City Deal project. This is a new inclusion to the Project. COS is funding the Masterplan preparation, but as yet, the delivery of these works are unfunded *upcoming*.

Next Community Consultation for Tourism Infrastructure Improvements – 6 February 2021

On Saturday 6 February there will be an onsite meeting (with online options available). This meeting will be an opportunity to hear about all the inputs to this important project and how your contribution will be included. Prior to this meeting, the Concept Plan will be available online from 15 January, with a link for comments and suggestions.
