Notice of Approval of Amendment

Amendment C85

The Minister for Planning has approved Amendment C85 to the Colac Otway Planning Scheme. The Amendment came into operation on 21 February, 2019.

The amendment rezones land at 558 Corangamite Lake Road (formerly known as 15 Factory Road), Cororooke from Township Zone (TZ) to Public Park and Recreation Zone (PPRZ) to facilitate the use and development of the land for public open space.
