Special Council Meeting

Wednesday 16 June

In accordance with Clause 11 of Council's Governance Rules, the Mayor has called a special meeting of the Council to be held on Wednesday 16 June 2021, at COPACC, 95 - 97 Gellibrand Street, Colac, commencing at 4pm.

The sole purpose of the meeting is to consider the following item of confidential business:

• **Consideration of the Appointment of a Chief Executive Officer.**

It is intended that Council, pursuant to sections 66(1) and 66(2)(a) of the *Local Government Act 2020*, will immediately close the meeting to members of the public to consider the above matter which deals with information that is confidential in accordance with section 3(1)(f) of the Act, being personal information which if released would result in the unreasonable disclosure of information about any person or their personal affairs.

As the only item of business to be transacted will be in closed session, we are not encouraging members of the public to attend.

Bluewater Leisure Centre to reopen

As per changes to COVID-19 restrictions for regional Victoria which came into effect yesterday, Bluewater Leisure Centre has re-opened to the public. Please note, as per State Government direction, the following restrictions apply:

- Bluewater and the 24/7 gym reopened from 6am today (Friday 11 June) with a maximum of 50 patrons per venue (e.g. gym area 50 people, stadium 50 people and pool area 50 people).

- Classes to have a maximum of 10 attendees, bookings essential.
