## Community Consultation -Councillor Code of Conduct

At the Council meeting on 24 November 2021, Colac Otway Shire Council resolved to seek public comment on the Councillor Code of Conduct.

The Local Government Act 2020 (Act) requires Council to develop and maintain a Councillor Code of Conduct (Code) that includes the standards of conduct expected to be observed by councillors that are prescribed in the Local Government (Governance and Integrity) Regulations 2020. A Code may also include any other matters which the Council considers appropriate.

The existing Code was adopted by Council on 24 February 2021. The Council resolution also stipulated that there be a review of the Code (to begin within nine months of the resolution being passed), with consideration to be given for public input.

From today (Friday 26 November 2021), copies of the Councillor Code of Conduct will be available:

- For inspection at Council's Rae Street office between 8.30am and 5pm (Monday to Friday) and at Apollo Bay Customer Service Centre (GORVIC) between 9am and 5pm.
- Online via Council's website.

At its scheduled meeting held on 26 August 2020, Council adopted the Governance Rules and Public Transparency Policy in accordance with the requirements of the Local Government Act 2020.

## Council also:

- Noted its previous resolution of 24 June 2020, recommending that the Governance Rules be reviewed within 12 months of adoption, with Council to consider a report in April 2021 in relation to commencing a review.
- Resolved at the 26 August 2020 meeting, that the Public Transparency Policy be reviewed within 12 months of adoption, with Council to consider a report in April 2021 in relation to commencing a review.



## Green Waste Skips - Wye River and Kennett River - extended for another week

The skips for green waste (only) which are located at Wye River and Kennett River will be in place for an additional week to assist residents to clean-up their property in preparation for fire season.



- Kennett River skip in place until Thursday 2 December
- Wye River skip in place until Friday 3 December

Please note, skips are for lighter green waste. Heavier green waste (large branches, cut trees) should be taken to the Apollo Bay Transfer Station.
