### **1. PURPOSE**

To consider the term of office for the Mayor.

### **2. EXECUTIVE SUMMARY**

Section 25(1) of the *Local Government Act 2020* (the Act) provides that Councillors must elect a Councillor to be Mayor of the Council.

Section 26(3) of the Local Government Act 2020 states:

"Before the election of the Mayor, a Council, other than the Greater Geelong City Council, must determine by resolution whether the Mayor is to be elected for a 1 year or a 2 year term."

### **3. RECOMMENDATION**

That Council resolves that the Mayor be elected for a term of ......year/s.

### **4. KEY INFORMATION**

Section 26 of the Local Government Act 2020 provides:

- *"(1)* A Mayor is to be elected no later than one month after the date of a general election.
- (2) The Mayor of the Greater Geelong City Council must be elected for a 2 year term.

- (3) Before the election of the Mayor, a Council, other than the Greater Geelong City Council, must determine by resolution whether the Mayor is to be elected for a 1 year or a 2 year term.
- (4) If the Mayor is elected for a 1 year term, the next election of the Mayor must be held on a day to be determined by the Council that is as close to the end of the 1 year term as is reasonably practicable.
- (5) If the Mayor is to be elected for a 2 year term, the next election of the Mayor must be held on a day to be determined by the Council that is as close to the end of the 2 year term as is reasonably practicable.

### **1. PURPOSE**

The purpose of this item is to elect the Mayor.

### **2. EXECUTIVE SUMMARY**

Section 25(1) of the *Local Government Act 2020* (the Act) provides that the Councillors must elect a Councillor to be Mayor of the Council at a Council meeting that is open to the public. Additionally, Section 25(3)(a) of the Act states that election of the Mayor must be chaired by the Chief Executive Officer.

Cr Kate Hanson was elected as Mayor of the Colac Otway Shire for a one-year term on 10 November 2021. Section 26(4) of the *Local Government Act 2020* states: "If the Mayor is to be elected for a 1 year term, the next election of the Mayor must be held on a day to be determined by the Council that is as close to the end of the 1 year term as is reasonably practicable."

Following the election, the Mayor shall assume the role of chair to deal with the remaining matters before the meeting.

### **3. ELECTION**

The Chief Executive Officer will call for nominations.

### **4. KEY INFORMATION**

Section 25 of the Local Government Act 2020 determines the method for the Election of the Mayor.

- *"25 Election of the Mayor*
- (1) At a Council meeting that is open to the public, the Councillors must elect a Councillor to be the Mayor of the Council.
- (2) Subject to section 167, any Councillor is eligible for election or re-election to the office of Mayor.
- (3) The election of the Mayor must—
  - (a) be chaired by the Chief Executive Officer; and
  - (b) subject to this section, be conducted in accordance with the Governance Rules.
- (4) Subject to subsections (5) and (6), the Mayor must be elected by an absolute majority of the Councillors.
- (5) If an absolute majority of the Councillors cannot be obtained at the meeting, the Council may resolve to conduct a new election at a later specified time and date.
- (6) If only one Councillor is a candidate for Mayor, the meeting must declare that Councillor to be duly elected as Mayor.
- (7) In this section, **absolute majority** means the number of Councillors which is greater than half the total number of the Councillors of a Council."

### **1. PURPOSE**

To establish an office of Deputy Mayor and determine the term of the Deputy Mayor.

### **2. EXECUTIVE SUMMARY**

Section 20A of *the Local Government Act 2020* (the Act) provides Council with the option to establish an office of the Deputy Mayor and elect a Deputy Mayor.

If Council resolves to elect a Deputy Mayor, the term of the Deputy Mayor must be determined by resolution to be for a one or two year term, prior to the election of the Deputy Mayor.

### **3. RECOMMENDATION**

### **4. KEY INFORMATION**

Section 27(2) of the Local Government Act 2020 (the Act) states:

*"Section 26 applies to the election of a Deputy Mayor as if any reference in that section to the Mayor was a reference to the Deputy Mayor."* 

Section 26 of the Local Government Act 2020 provides:

- *"(1)* A Mayor is to be elected no later than one month after the date of a general election.
- (2) The Mayor of the Greater Geelong City Council must be elected for a 2 year term.
- (3) Before the election of the Mayor, a Council, other than the Greater Geelong City Council, must determine by resolution whether the Mayor is to be elected for a 1 year or a 2 year term.
- (4) If the Mayor is elected for a 1 year term, the next election of the Mayor must be held on a day to be determined by the Council that is as close to the end of the 1 year term as is reasonably practicable.
- (5) If the Mayor is to be elected for a 2 year term, the next election of the Mayor must be held on a day to be determined by the Council that is as close to the end of the 2 year term as is reasonably practicable.

...".

### **1. PURPOSE**

The purpose of this item is to elect the Deputy Mayor.

### **2. EXECUTIVE SUMMARY**

Section 20A of the *Local Government Act 2020* (the Act) provides Council with the option to elect a Deputy Mayor.

Cr Graham Costin was elected as Deputy Mayor of the Colac Otway Shire for a one-year term on 10 November 2021.

Section 27(1) of the Act requires that the procedure for the election of the Mayor will apply to the election of the Deputy Mayor, with the Mayor conducting the election.

### **3. ELECTION**

The Mayor will call for nominations.

### 4. KEY INFORMATION

Section 24 of the Act, Election of the Deputy Mayor, states "Section 25, other than subsection (3)(a), applies to the election of a Deputy Mayor by the Councillors as if any reference in that section to the Mayor was a reference to the Deputy Mayor."

*"25 Election of the Mayor* 

- (1) At a Council meeting that is open to the public, the Councillors must elect a Councillor to be the Mayor of the Council.
- (2) Subject to section 167, any Councillor is eligible for election or re-election to the office of Mayor.
- (3) The election of the Mayor must—
  - (a) be chaired by the Chief Executive Officer; and
  - (b) subject to this section, be conducted in accordance with the Governance Rules.
- (4) Subject to subsections (5) and (6), the Mayor must be elected by an absolute majority of the Councillors.
- (5) If an absolute majority of the Councillors cannot be obtained at the meeting, the Council may resolve to conduct a new election at a later specified time and date.
- (6) If only one Councillor is a candidate for Mayor, the meeting must declare that Councillor to be duly elected as Mayor.
- (7) In this section, **absolute majority** means the number of Councillors which is greater than half the total number of the Councillors of a Council."
