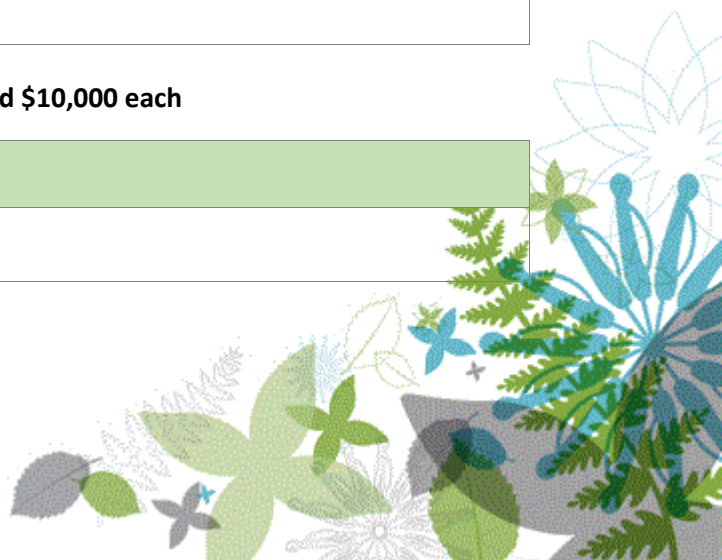

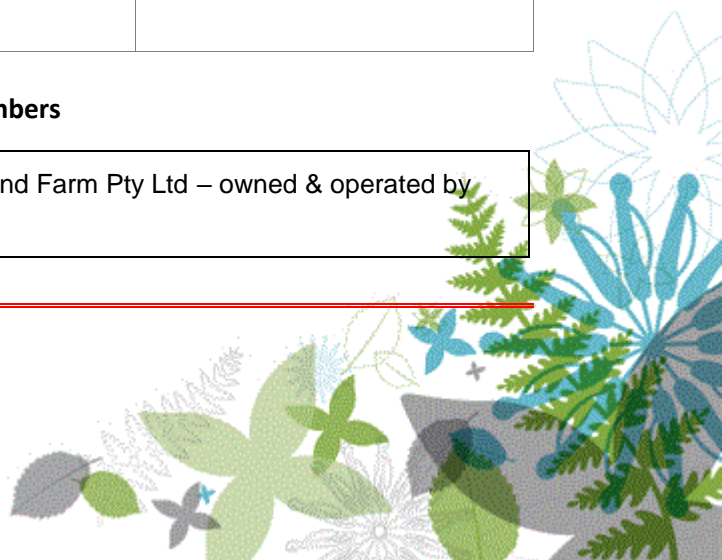

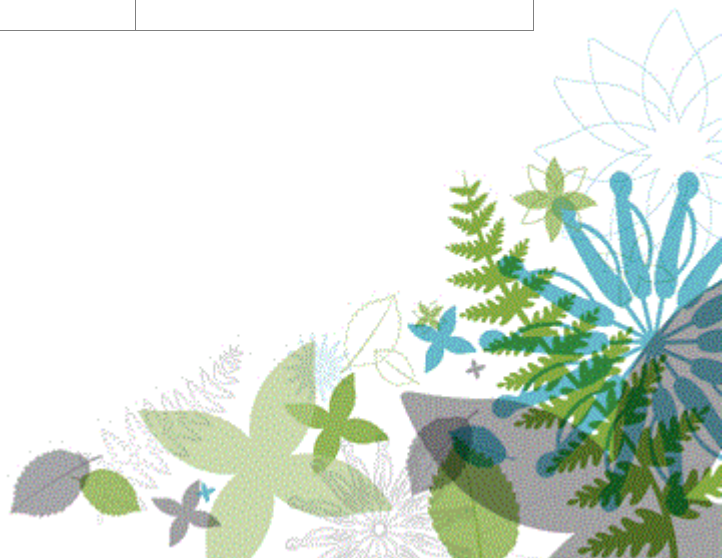

I only receive anything from the Trust if I survive the life tenant. Based on the current balance, if the Trust ceased today, I estimate my interest to be worth less than \$10,000.
