Assassins Weed and Vermin Control

During 2013/2014 and 2014/2015 Council has paid \$184,554 to Assassins Weed and Vermin Control.

In June 2013 following a quotation process undertaken a quotation from Assassins was accepted. This was originally for the Shire's weed management program for 2013/2014.

Eight quotations were received for the program following advertising on tenderlink.

For 2013/2014 expenditure under the quotation amounts to \$94,353.

In August 2014 a letter was written to Assassins extending the contract arrangements with Assassins for a second year (2014/15). No quotation process was undertaken. As a result of additional work being undertaken due to additional funds available an amount of \$90,201 was expended in 2014/2015.

The cumulative effect is that over a 2 year period \$184,554 was expended.
