<p>Amendment Application</p>	<p>(b) Under Section 57A(3)(a) of the Act the fee to amend an application to amend a permit after notice is given is 40% of the application fee for that class of permit set out in Table 3 at Regulation 11 (Permit Amendment Fees) and any additional fee under c) below (c) If an application to amend an application for a permit or amend an application to amend a permit has the effect of changing the class of that permit to a new class, having a higher application fee set out in Table 2 to Regulation 9, the applicant must pay an additional fee being the difference between the original class of application and the amended class of permit</p>
