QUESTIONS RECEIVED IN WRITING PRIOR TO THE MEETING

James Judd

1. As the fourth year since the Council signed a contract with the operators of the holiday park is fast approaching, is this Council able to give an definitive guarantee that renewable electricity will actually be deliverable to Colac in advance of that date?

Response from General Manager Community and Economy

The commencement date of the Lake Colac Holiday Park lease was 1 January 2024. Therefore, the tenant will need to meet the requirement regarding the use of renewal energy as stipulated in the lease by 31 December 2026. Ensuring that the lessee meets this requirement, along with all other clauses in the lease, will be dealt with as part of the management of the lease.

Elizabeth Ryan

1. Could Council please provide an update on the proposed safety works for Conns Lane/Cape Otway Road, Birregurra?

Response from General Manager Infrastructure and Environment

The signs related to change in speed limits in Conns Lane and Cape Otway Road have been ordered from a supplier and will be installed as soon as they are received. We expect this to be within the next fortnight.

Graham Costin

The following proposed footpath links in Apollo Bay will provide strategic pedestrian connections between the recreation reserve, campground, shopping centre, Barham River mouth, Pt Bunbury Walk, and the harbour precinct. These paths already experience significantly higher pedestrian and traffic volumes than Noel Street, yet unlike Noel St are not currently classified as Priority 1.

We respectfully request that Council reclassify the following Apollo Bay footpaths as Priority

- Cartwright Street Noel Street to Nelson Street
- Cartwright Street Gambier Street to Noel Street
- Gambier Street Cartwright Street to Sylvester Street (Great Ocean Road)

Given their strategic location and high usage, upgrading the classification of these footpaths will more quickly improve safety, accessibility, and amenity for both residents and visitors.

1. Will Council reclassify the above footpaths as Priority 1 in recognition of the higher pedestrian and traffic volumes in these streets and their critical role in linking community, recreation, camping and commercial precincts in Apollo Bay?

Response from General Manager Infrastructure & Environment

The classification methodology used in undertaking the review prioritised footpaths that provide direct access to the Great Ocean Road, as they provide important linkages to key amenities such as childcare, health facilities and shops whilst addressing pedestrian risk due to traffic flow. This is the primary reason why Noel Street was given higher priority than Cartwright Street.

QUESTIONS RECEIVED VERBALLY AT THE MEETING

Tony Webber

1. Mr first question relates to last meeting where I asked about the 196 kilometres mark from Melbourne on the Great Ocean Road. Now, Mr. Singh rang me about it and I wasn't at home and then I rang him back and left a message and I haven't heard anything since. Could I have an update on what's happening?

Response General Manager Infrastructure and Environment

Through you Mayor, I will take this on notice and get Mr Singh to give you a call back following this meeting.

2. The second question is on the footpath strategy. I've been requested by people in Murray Square to ask if they could be put on the list, because there is a lot of elderly people there and, Murray Square doesn't have a proper footpath situation. So, could that happen?

Response Mayor Cr Schram

We've got that strategy before us to make a vote on today and there can be an alternative motion, but we can't sort of determine that until we get to that item.

3. There are also problems with the Sand road. I don't know if anyone's been aware of that and I think it needs regular maintenance rather than occasional maintenance. So, can that also be considered?

Response General Manager Infrastructure and Environment

Sand Road has been in a poor condition for some months and we're well aware of that. It obviously is an important road that services the community in Glenn Air as well as the campground. There is some cultural heritage areas underneath the road and council requires a permit from Eastern Maar to be able to undertake maintenance works. Council's engaged a consultant to do an assessment of those values and we lodged an application with EMAC, and we are hoping to be able to get approval to undertake those works shortly.

4. The top of Montrose Avenue is quite a busy road. Maybe that could be put on the list for the next road to be upgraded in Apollo Bay because it's from the industrial state,

the tip. A lot of people and large vehicles use that road. Maybe that could go on a priority list for the next road upgrades.

This was interpreted as a statement which was noted by Council; therefore, no response was provided.

Elizabeth Ryan

1. My question relates to the submission meeting which I attended a couple of weeks ago. There were no questions asked from you to the gallery. There was so much to learn, especially about for me Meredith Park, and I think I'd like to suggest that the public is more considered, that could council then consider that submissions be shared with the public and reopen to further input, prior to council voting on those matters?

Response Mayor Cr Schram

The submissions meeting is an opportunity for the public to speak to their submissions. So we can hear them, and they can better explain it. It's not a question-and-answer forum.

Response General Manager Community and Economy

If we use Meredith Park as an example, so council's gone out for community engagement and part of the community engagement process is the submissions committee meeting, like the Mayor said, where people can talk to their submission.

We then collect and analyse all the submissions and the feedback that we get through the survey and then bring that to council through a council report where we'll provide that assessment through that council report. That's the process. The Submissions Committee meeting is just one part of the consultation process if that makes sense, and then we'll analyse and provide an overarching report to Councillors.

2. My other question relates to Item 7.2 of todays agenda, the review of footpath strategies. I'd like to encourage council to consider that included part of this new road safety strategy that's happening at the moment. I think that is integral to the strategy. My two questions relate to other inclusions that should have been considered in the review of the strategies.

There's your nature strip policy; I think that the footpath and nature strips go hand in hand. So that would be handy that they were together.

And also, a document, I know it's very old, but I found it and it was dated June 2004 and it's called safer roads. It's a local road safety initiative looking out for pedestrians. I think it was put together by road safe groups. I think that would be helpful.

My other question then goes on to relate to the road safety strategy. I learned about it through the Colac Herald last week. I then downloaded it from the website and now I've looked at it again today and there's a poll and a survey which I was totally unaware of. Just want to know what changed and why it wasn't up there initially, please. And will the public be notified?

Response General Manager Infrastructure and Environment

I'm happy to follow up and query whether that was there initially or not but certainly would encourage any member of the community who's interested in making any form of comment about priority safety issues to go on to that web page and to register what you think of the important safety issues are.
