1 DECLARATION OF OPENING OF MEETING

Chief Executive Officer - Andrew Tenni

"Good afternoon. I formally declare open this meeting of the Colac Otway Shire Council of the **18 November 2025.**

My name is Andrew Tenni, and I am the Chief Executive Officer of the Colac Otway Shire Council.

I would like to start this afternoon by acknowledging the traditional custodians and law makers of this land, their elders past, present and emerging.

Today Council will elect the Mayor for the Council in accordance with Sections 25-27 of the Local Government Act 2020.

Council may also elect a Deputy Mayor at this meeting in accordance with the Act.

Section 25(3)(a) of the Local Government Act 2020 requires that the election of the Mayor be conducted by the Chief Executive Officer.

Once the election of the Mayor has occurred, I will vacate the Chair and the elected Mayor will assume the role of Chair for the remainder of the meeting.

I would like to advise that all Council meetings are recorded and live streamed, with the exception of confidential matters. This includes the public participation sections of meetings. The live stream recording of this afternoon's meeting will be available on the website as soon as practicable."

Response from General Manager Infrastructure and Environment

The electricity supply to Colac currently includes power from renewable sources.

Question is in relation to Elliminyt Wetlands project.

2. How will that development be of any value to all areas north and east of that project? Or will they still remain subject to uncontrolled flooding that this area has long suffered from.

Response from General Manager Infrastructure and Environment

The Elliminyt Wetlands redevelopment project will result in reduced downstream flooding within the Deans Creek catchment by retarding some of the overland stormwater flow currently experienced on low lying land in high rainfall events.

1. Can you please tell me the council's definition of a dangerous dog.

Response General Manager Infrastructure and Environment

Council does not define what a dangerous dog is. A dog can be declared as dangerous under the Domestic Animals Act 1994 if....

- 1. The dog has caused death or *serious injury to a person or another animal by biting or attacking that person or animal; or
- 2. If the dog has been declared 'menacing' and the owner has received at least two infringement notices with respect to various other offences regarding the control and management of a 'menacing' dog; or
- 3. The dog has been declared 'dangerous' by another state or territory; or
- 4. There has been a finding of guilt (or the serving of an infringement notice) with respect to two or more offences relating to dog attacks or rushing
