The land affected by the application is located at:

The application is for a permit to:

Works Associated with the use of land for Utility Installation (pipeline - replacement and upgrades) and Removal of Vegetation (Native and Non-Native) with Ancillary laydown areas.

42.03-2	Remove, destroy or lop any native vegetation in the Significant Landscape Overlay (SLO1)
44.01-3	Remove, destroy or lop any vegetation in the Erosion Management Overlay (EMO1)
52.17-1	Remove, destroy or lop native vegetation, including dead native vegetation

Any person who may be affected by the granting of the permit may object or make other submissions to the responsible authority.

An objection must be made to the responsible authority in writing, including the reasons for the objection and state how the objector would be affected.

The responsible authority must make a copy of every objection available at its office for any person to inspect during office hours free of charge until the end of the period during which an application may be made for review of a decision on the application.

The responsible authority will not decide on the application before **30 May 2025**.

If you object the responsible authority will tell you its decision.
