Notice of exhibition of Draft Apollo Bay Harbour Development Plan

Colac Otway Shire Council has prepared a draft Development Plan for Apollo Bay Harbour. The Development Plan has been prepared in accordance with Clause 37.01 - Special Use Zone of the Colac Otway Planning Scheme.

The land affected by the Development Plan is the Apollo Bay Harbour and immediate surrounds.

The purpose of the Development Plan is to guide the form of future development of the Apollo Bay Harbour, and attract further investment.

Any interested person may make a submission to Council about the Development Plan. #### **COVID-19 Rates Payment Assistance**

The rates you pay enable Colac Otway Shire Council to provide more than 40 services across the shire, from maintaining our streets, roads and sporting grounds to delivering community grants and maternal and child health services.

This year, we are also providing COVID-19 support to vulnerable residents, businesses and the wider community. It is therefore vital that we all pay our rates to ensure these services can continue to be provided.

However, we understand this may be difficult for some people and we encourage you to either pay by quarterly instalment, (with your first quarterly instalment by 30 September 2020), or make an arrangement to make more frequent, manageable payments. Due to COVID-19, Colac Otway Shire

ratepayers with rate notice arrears will not be charged interest on those arrears until 31 December 2020.

However, we urge anyone experiencing difficulty paying to contact Council's Rates Team and discuss payment arrangements now, to help avoid further financial pressure in 2021.

Arrange to pay weekly, fortnightly or monthly and importantly, keep in touch, so we can continue to assist.

Old Coach Road, Skenes Creek - Community Consultation on **Proposed Changes** 

Council has been working with residents on Old Coach Road, Skenes Creek to try and resolve reported traffic issues.

Old Coach Road is classified as a public roadway and under the Road Management Act 2004. As the installation of 2 gates would restrict public access to the northern section, the classification of this section would need to be formally gazetted. Council, as the management authority for the road, may change the classifica of the road to a 'controlled access road', however the proposal must be advertised and public consultation undertaken.

A further round of the Communities Combating Pests and Weeds grant opportunity for spring and early summer 2020 has been announced. The grant enables Council to support private property owners across the shire in their efforts to control weeds and rabbits on their properties.

The grant program requires private landowners to contribute a dollar for dollar amount equivalent to what they receive through the grant for works on their land.
