## NOTICE OF AN APPLICATION FOR PLANNING PERMIT

**The land affected by the application is located at: 3A Ricstan Court ELLIMINYT**

**The application is for a permit to:** Removal of Reserve No. 1 (Municipal Purposes) to Create a Road R1

A permit is required under the following clauses of the planning scheme.

**Planning scheme clause:** 52.02

**Matter for which a permit is required:** Section 24A of the Subdivision Act 1988 to remove Reserve no.1 status and Create Road R1.

**The applicant for the permit is:** Colac Otway Shire Council

This can be done during office hours and is free of charge.

Any person who may be affected by the granting of the permit may object or make other submissions to the responsible authority.

An objection must be made to the responsible authority in writing, include the reasons for the objection and state how the objector would be affected.

The responsible authority must make a copy of every objection available at its office for any person to inspect during office hours free of charge until the end of the period during which an application may be made for review of a decision on the application.

**The responsible authority will not decide on the application before 22 August 2025.**

If you object the responsible authority will tell you it's decision
