



#### 5. QUESTION TIME

#### **QUESTION TIME BEGAN AT 2:31pm**

#### Alan Billing - Larpent

1. My reading of the document indicates there are significant changes that will impact on how the Council operates in the community, why was there such short notice of the meeting today?

General Manager Corporate Services responded that in accordance with the Local Law, the advertisement for the meeting was placed seven days beforehand on the Colac Otway Shire website and as soon as practicable in the newspaper. The appropriate notice was provided to call this meeting.

2. It would be valuable to note that where clauses are changed, that those changes be noted.

General Manager Corporate Services responded that the legislation has required some significant and fundamental changes to the Councillor Code of Conduct and the tracked changes version in this particular case would not have helped understanding as there is a fundamental significant change to the way Council is required to comply with the Act.

3. Why is this document not going out for public comment?

General Manager Corporate Services responded that legislation states that this document can only be adopted by Council and that it must be adopted through a

Special Council Meeting process. The document has been prepared in collaboration with Council and only Council can decide on the format of this document.

4. Does the Local Government Act prohibit this document going out for public consultation?

General Manager Corporate Services responded that the requirements of the Local Government Act is that Council is the only authority that can adopt the Councillor Code of Conduct. In this case it has been submitted through the appropriate process and in accordance with the Act.

#### Noel Hanlon - Irrewarra

1. If I met up with a Councillor in public and a matter of public information is discussed, is it correct that I cannot receive information from the Councillor unless the Mayor approves of it?

General Manager Corporate Services responded that the document does not stop the democratic process and allows constituents to engage with Councillors
