1. PURPOSE

To provide a report to Council on the submissions received in response to the Notice of Intention to Close Road (part) Hall Street Cressy.

2. EXECUTIVE SUMMARY

On the 22 February 2023, Council Resolved to enter into the Statutory Process to close part of the road known as Hall Street Cressy. A Notice of Intention to Close the Road was advertised in the Colac Herald and on Council's website on the 24 February 2023, seeking submissions from interested parties that wish to make their view on the proposed closure known to Council. The notice called for submissions to be received prior to 2pm on Friday 14 April 2023.

A 'drop-in' information session was held by Council on 30 March 2023 at the Cressy Hall. A number of Residents attended the session.

In response to the notice, seven submissions have been received by Council. The submissions contained one request to be heard. Council officers contacted other submitters to confirm that there was an option to speak to the submission at a Submissions Hearing. As at the time of preparation of this Report, a total of two submitters have asked to be heard.

3. RECOMMENDATION

That the Submissions Committee:

- 1. Acknowledges the submissions received.
- 2. Thanks the submitters for their contribution to the submission process.
- 3. Having heard all persons wishing to speak to their submissions, recommends that Council consider all submissions at a future Council meeting.

4. KEY INFORMATION

Submissions received are attached and summarised as follows:

Submission 1

This Submission supports the part road closure; a summary is as follows:

- a) No access restrictions to other properties.
- b) Private ownership of historical buildings.
- c) Unwanted behaviour of visitors passing by the former hotel.
- d) A desire for privacy.
- e) Proposal to install a "viewing board" with historical information.
- f) Satisfaction with the current proposal of part closure.

This Submitter has asked to be heard in a public Submissions Hearing.

Submission 2

This Submission is not in support of the part road closure; a summary is as follows:

- a) Satisfaction with the way the street is currently.
- b) The possibility that the part road closure may restrict fire truck access.
- c) A request to make the road in the road reserve.

This Submitter has not asked to be heard

Submission 3

This Submission is not in support of the part road closure; a summary is as follows:

- a) Road 'provides only safe and legal place to ride on a surfaced area '
- b) 'Is a heritage overlay and changing the road would change the whole landscape.'
- c) The ability of others to use the area.

This Submitter has not asked to be heard.

Submission 4

This Submission is not in support of the part road closure; a summary is as follows:

a) 'This historical site needs to be preserved and remain visible.'

This Submitter has not asked to be heard.

Submission 5

This Submission contains suggestions; a summary is as follows:

- a) Suggests that the 'road reserve to be a footpath so people can take photographs of the old hotel.'
- b) Refers to the History Discovery Trail in the township of Cressy as an important factor.

This Submitter has not asked to be heard.

Submission 6

This submission is not in support of the part road closure; a summary is as follows:

- a) There have not been issues with Hall Street in the past.
- b) 'As Cressy CFA Captain, I have concerns about fire vehicle access and therefore safety of my crews and community'.
- c) Suggests that an all-weather road is needed.
- d) Advises that the fire brigade have a new large vehicle on order and the current proposal will not allow the vehicle access.
- e) Offers to consult with the Colac Otway Shire about suggested changes.
- f) Refers to new development in Hall Street that may require large trucks to reverse out.
- g) Hall Street is a place where grain trucks can turn around.

This Submitter has asked to be heard

Submission 7

This Submission is not in support of the part road closure; a summary is as follows:

- a) Would like to see no change at all.
- b) Is used by residents for leisure purposes.
- c) Asks questions about who paid for construction of the road.
- d) Asks questions about the current former hotels owner's knowledge.
- e) Remarks that large trucks would have difficulty turning around in Cressy.
- f) Would prefer other options in Council report.

This Submitter has not asked to be heard.
