HOW TO APPLY FOR WRITTEN CONSENT

Completing the Application Form

The Applicant	 Give your full name or the name of the company. Give your full postal address and your contact phone number.
The Owner	 If the applicant is not the owner, give the owner's name and address.
The Land	 Give the street number, street name, town and postcode. If you cannot give this information, than you must give- The lot number and lodged plan number; or The Title particulars; or The Crown Allotment particulars

The Use /	You must either:
Development	 Describe fully what you want to do with the land
	 Describe fully the existing use and development on the land.

Supporting Information

You <u>must</u> give full details of your proposal of the Written Consent, and attach supporting documents with your application, which may include:

- Copy of Title (not more than 60 days old) including plan of subdivision and all covenants and Section 173 Agreements.
- Site Plan (minimum A3 size) fully dimensioned and to scale showing outline of building envelope, proposed structure/building indicating encroachment outside building envelope and setbacks from boundaries
- Plans of proposed development, fully dimensioned and to scale (e.g. floor plans and elevations)
- Schedule list of the proposed works and intended use
- Letter from developer (if applicable) stating whether proposal is approved and in accordance with the Estate's Design Guidelines
- Prescribed fee

Note

Please note that Consent may not necessarily be obtained via this process and you may be required to apply for a planning permit to vary or remove a restrictive covenant or a restriction. You should seek advice from your solicitor before lodging this form.
